1. Acceptance Offer

- 1.1. The MESPOM Consortium is jointly offering the two-year Master's Degree Program in Environmental Sciences, Policy and Management Program (hereinafter the "Program") starting in 2023/24 academic year.
 - The Program is financially supported by the European Union through the Erasmus+ Program administered by the Education, Audiovisual and Culture Executive Agency.
- 1.2. Subject to section 1.3 the MESPOM Consortium accepts the Student into the Program on the Lund Track starting in 2023/24 academic year, from 1 September 2023 ending with 31 August 2025 in the academic year 2024/25.
- 1.3. As a precondition for enrolment in the Program the Student must submit official academic documentation of completion of the relevant degree (see https://www.ceu.edu/after-you-apply/accepted-students/academic-records).
- 1.4. The Student undertakes to submit copies (digital or paper) of the aforementioned official academic documents until 31 July 2023 to Central European University Private University, Admissions Office.

2. Financial Details

2.1. The Student has been awarded an Erasmus Mundus Joint Master's Scholarship of the European Union (hereinafter "EMJM Scholarship"):

The Student will receive a maximum amount of EUR 33.600,00 for the whole period of his/her/their study (twenty-four months). The EMJM scholarship is calculated on the basis of a monthly rate of EUR 1.400,00 pro-rated for the actual number of days of the Student's study starting from 1 September 2023 and depending on the actual date of the Student's arrival and leave. CEU will be paying the EMJM Scholarship on behalf of the MESPOM Consortium on a monthly basis by direct transfer to the Student's bank account. Bank charges or fees, if any, for the disbursement of the EMJM Scholarship to the Student have to be paid by the Student. See attached EMJM Scholarship Payment schedule in Annex A for details.

- The EMJM Scholarship is non-transferable,
- termination of enrolment will result in automatic cancellation of the EMJM Scholarship,
- the Student must not benefit from another EU funded scholarship scheme for the entire period of enrolment in the Program,
- the Student must not have already benefited from a previous EMJM Scholarship,

- the Student must have at the time of enrolment a first higher education degree (or demonstrate a recognized equivalent level of learning according to national legislation and practices in the degree-awarding countries),
- the Student must fulfill the EMJM Scholarship's minimum mobility requirements: the Student is expected to spend at least two study periods in two countries which are different from the country of residence of the Student at the time of enrolment ("Mobility Periods") and of which at least one country is an Erasmus+ Program Country. Each of the two study periods must correspond to a workload of at least one academic semester (30 ECTS credits or equivalent). Mobility Periods cannot be replaced by virtual mobility (distance learning). In case the Student does not fulfill the aforementioned mobility requirements the Student's EMJM Scholarship may be reduced. The percentage of reduction may amount up to the percentage of the missing mobility period in proportion to the concerned academic semester,
- the EMJM Scholarship payments may be suspended, if the Student is forced to temporarily interrupt his/her/their studies (following the declaration of duly justified and well documented reasons) but will resume them afterwards, provided that the Program is still ongoing.
- 2.2. The Student's **private insurance will be paid for by CEU and provided by Expat & Co** (http://www.expatinsurance.eu/), covering the minimum requirements for the health and accident insurance coverage required for Erasmus Mundus Joint Master's programs. The insurance is effective from 15.08.2023 until 31.10.2025. If the Student discontinues the Program for any reason, the aforementioned insurance will also be terminated.
- 2.3. The Student will be responsible for paying all other expenses associated with their studies, including but not limited to accommodation, visa/residence permit and travel.

3. Residential & Travel Arrangements

The Student is responsible to arrange his/her/their own visa and/or residence permit with the documents provided by and with the help of the Consortium universities' Student Services. The Student is responsible for arranging his/her/their own travel to and from the Consortium universities.

4. Study program and academic regulations

- 4.1. By being admitted to the Program, the Student is entitled to participate in the Program in accordance with the MESPOM program description available at the MESPOM website (www.mespom.eu).
- 4.2. Upon successful completion of the Program, the Student is awarded the Master of Science degree in Environmental Sciences, Policy and Management. The MESPOM degree is a valid national degree in Sweden, the UK, Greece and Austria supported by four separate degree certificates. In addition, the MESPOM Program is accredited in the USA by the New York State Department of Education.
- 4.3. The key elements of the Program, such as mandatory Mobility Periods, academic calendar, grading structure, thesis and final examination requirements as well as rights and responsibilities under the Program are regulated in the MESPOM Handbook (https://mespom.eu/sites/mespom.eu/files/attachment/basicpage/286/mespomhandbook2022-23final4.pdf), which is an integral part of this agreement.
- 4.4. Unless specifically regulated by the MESPOM-wide policies and procedures contained in the MESPOM Handbook, the policies and procedures of the Consortium university where a student is hosted at a given moment (hereinafter the "Host Consortium university") apply to the Student. As these vary from one institution to another, the Student is strongly advised to carefully study applicable policies and procedures of each Host Consortium university, Semester dates of the Host Consortium universities
 - CEU: 1 September 2023 29 March 2024
 - UAegean: 1 April 2024 5 July 2024
 - LU: 2 September 2024 19 January 2025

UoM: 23 September 2024 - 24 January 2025

• The Student will spend the thesis semester, which lasts from 1 February 2025 until June 2025, at one of the Consortium universities (as explained in the MESPOM handbook).

5. Data Protection

- 5.1. - 5.2. The data processing of each Consortium university is subject to their individual Privacy Notices (CEU: https://www.ceu.edu/sites/default/files/attachment/basic_page/21822/ceupustudentpn.pdf; LU: https://www.lunduniversity.lu.se/about-university/contact-us/privacy-policy; UoM: https://www.manchester.ac.uk/discover/privacy-information/data-protection/UAegean: https://kedivim.aegean.gr/en/privacy-policy/).

6. Participation in E+ and EMJM activities

For the purposes of monitoring, evaluation and improvement of the E+/Erasmus Mundus program and the Program, the Student is expected to participate in mandatory evaluations/surveys conducted by the MESPOM Consortium and/or the European Commission (including the European Agency for Culture, Education and Audiovisual). The Student is also strongly encouraged to join the Erasmus Mundus Students and Alumni Association (EMA) (see http://www.em-a.eu/)

7. Miscellaneous

7.1. The present agreement is concluded for the duration of the Student's enrolment in the Program and may be terminated by the MESPOM Consortium with immediate effect at any time for good cause. Good cause is constituted by substantial violations of the Student's obligations according to the present agreement, the policies of the Host Consortium

university or the MESPOM Handbook, in particular excessive absence, violations of academic

honesty and integrity or failure to meet the required financial obligations.

7.2. Any amendment to the present agreement shall be made in writing by mutual consent of all

parties, including amendments of this written form requirement.

7.3. The invalidity or unenforceability of any provision of the MESPOM study agreement shall not

affect the validity or enforceability of any other provision of the MESPOM study agreement

which shall remain in full force and effect.

7.4. The present agreement does not replace individual study agreements between the Student

and a Consortium university, if any. In case of a contradiction between the present

agreement and an individual study agreement of the Student relating to the Program with a

Consortium university, the provisions of the individual study agreement between the

Student and the Consortium university shall prevail.

7.5. The Student is obligated to inform the Coordination Team at coordinator@mespom.eu

without undue delay of any events or circumstances (eg moving the place of residence) that

potentially interrupt or delay the Student's studies, affect the Student's required mobility or

any other obligation of the Student under the present agreement.

8. Applicable law and jurisdiction

8.1. The present agreement shall be governed by the laws of the country in which the Student's

place of residence is located.

8.2. Any dispute between the Student and a Consortium university arising out of or in connection

with the present agreement shall be resolved by amicable solution through the applicable

policies and procedures at the Consortium university with which the dispute originated or

the MESPOM institutions as stipulated in the MESPOM Handbook. In case these negotiations

fail, the competent court at the Student's place of residence shall have exclusive jurisdiction.

1. Acceptance Offer

1.1 Central European University New York and Central European University Private University accept the Student beginning with **1 September 2023** as a student enrolled in the

5. Miscellaneous

- 5.1 This agreement is concluded for the duration of the Student's studies at CEU and may be terminated by CEU with immediate effect at any time for justified reasons including, but not limited to: a serious or repeated violation of the obligations of the Student hereunder, in particular excessive absence, failure to maintain the minimal Grade Point Average ("GPA"), violations of academic honesty and integrity, failure to meet the required financial obligations, or other serious infractions.
- 5.2 For issues that are not regulated in this agreement, CEU's policies, specifically the <u>Student Rights</u>, <u>Rules and Regulations Policy</u> shall be applicable.
- 5.3 The Student is and remains author of all works created by him/her at CEU. The Student, however, grants CEU the non-exclusive, perpetual, irrevocable, assignable and royalty-free worldwide license, to use any work protected by copyright created by the Student within the scope of this study agreement for CEU's academic, research, educational, promotional and administrative purposes.
- 5.4 At CEU we place great emphasis on the protection of the students' personal information and compliance with the applicable data privacy requirements, including specifically the EU General Data Protection Regulation (GDPR). CEU informs the Student that its data processing activities are primarily based on the provisions of the relevant Austrian educational and financial legislation or are necessary

for the fulfillment of this contract or the legitimate interest of the Data Controller. Should the consent of the data subject be required for any data processing activity, CEU will always obtain it from the Student. - 5.6 This agreement shall be governed by the laws of the Republic of Austria without regard to its conflict of law provisions. The competent court in Vienna, Austria shall have exclusive jurisdiction for any dispute arising from or in connection with this study agreement.
